Land Use Trends in South Florida



South Florida's land market continues to transform as population growth, new legislation, and redevelopment shape the region's future. Florida remains one of the fastest-growing states in the nation, and in Broward County, strong job growth and a favorable tax environment are drawing companies and high-net-worth residents. This growth is fueling land demand in key suburban markets including Plantation, Weston, Pembroke Pines, Sunrise, and Cooper City.

Plantation is experiencing strong momentum around Midtown and the I-595 corridor, driven by demand for medical office, multifamily, and retail. Weston continues to thrive as a premier residential community, where scarce commercial land is creating opportunities for office and lifestyle-focused retail projects. In Pembroke Pines, development along Pines Boulevard and City Center is being fueled by redevelopment opportunities, while Sunrise and Cooper City are expanding with new residential and commercial activity as families and businesses look beyond Miami's urban core.

At the same time, land sales remain strong statewide. In South Florida, smaller parcels trade at significantly higher per-acre prices compared to other parts of the state. Developers are increasingly pursuing mixed-use projects that blend residential, retail, and office space to meet shifting lifestyle demands, particularly with the rise of remote and hybrid work.

Policy and zoning shifts are also shaping the market. The Live Local Act of 2023 continues to encourage higher-density, mixed-use projects focused on affordable housing. However, many local governments face challenges balancing approvals with infrastructure and long-term growth concerns. As growth accelerates, protecting South Florida's natural resources is becoming more urgent. The South Florida Water Management District (SFWMD) plays a vital role in balancing development with conservation to ensure the sustainability of our environment.

South Florida's land market is moving quickly. For property owners, developers, and investors in Plantation, Weston, Pembroke Pines, Sunrise, and Cooper City, staying ahead of land use trends is essential to making informed decisions.
